By leaving an application on this website, you consent to the collection, use and transfer of your information to Cosmos Group, LLC (INN 9717048620), located at: 13 bld. 1 Milyutinskiy per., Moscow, 101000, Russia, on the following conditions:

1. Personal Data processing shall mean any action (operation) or complex of actions (operations) performed with or without the use automatic means.
2. The Personal Data may include the following information on you: your name and surname; your contact information (address, phone number and e-mail); place of work and your status in the Company; your user data (location information, OS type and version, Browser type and version of the browser, type of device and display resolution, the source from where the user came from (site or advertising), OS and Browser language, what pages are opened and what buttons are pressed; ip-address).
3. The Personal Data is not publicly available.
4. Your information will enable us to contact you when necessary concerning your orders. We will also use and analyze the information we collect so that we can administer, support, improve and develop our business. In particular, we may use your information to contact you for your views on our services and to notify you occasionally about important changes or developments to the website or our services.
5. Cosmos Group's Personal Data processing policy is based on the following statutory acts: Art. 24 of the Constitution of the Russian Federation; Article 6 of the Federal Law No. 152-FZ "On Personal Data"; the present Consent to the processing of personal data.
6. Personal Data processing shall mean any action (operation) or complex of actions (operations) including collection; recording, systematization; compilation; storage; adjustment (updating and amending); retrieval; use; transfer (distribution, presentation, and access) including cross-border transfer; anonymizing; blocking; deletion; and destruction of Personal Data.
7. Personal Data is processed until the individual's unsubscription from advertising and newsletters. In addition, Personal Data processing can be terminated at request of the subject of Personal Data. Personal Data Storage is carried out in accordance with The Russian Federation Government Resolution No. 512 'On Approving the Requirements to Biometric Personal Data Tangible Carrier and Such Data Storage Beyond Personal Data Information Systems'.
8. The present Consent for Personal Data processing may be withdrawn at any moment by addressing of a letter of withdrawal of Consent for Personal Data processing to the address of Cosmos Group, LLC: 13 bld. 1 Milyutinskiy per., Moscow, 101000, Russia.

In case of withdrawal of Consent for Personal Data processing, Cosmos Group LLC may continue processing Personal Data without the consent of the personal data subject if there are grounds specified in clauses 2 Article 10 and Part 2 of Article 11 of the Federal Law No. 152-FZ "On Personal Data" dated July 27, 2006.
10. The present Consent is provided for the unlimited period until it is revoked, according to conditions specified in clauses 7 and 8 of this document.
